Failure to cancel a boarding stay at least 5 calendar days in advance will result in the loss of the deposit. Applicable fees for any services are those in effect on the date a pet is checked into Canine Kingdom or comes to Canine Kingdom for a service, and not those in effect when the appointment or reservation is made (if earlier). Owner is responsible for any damage of property caused by their pet during any stay for any reason. Rates are subject to change without prior notice. If any fees or expenses payable by you are not paid within ten (10) days after they are due, or if your pet is not claimed within ten days of its scheduled pick up date, Canine Kingdom reserves the right to exercise any and all remedies available to it at law or in equity, including, without limitation, in accordance with applicable law. You agree to promptly notify Canine Kingdom of any change in the scheduled pick up date.
